HOW LONG DOES PRE-ENROLLMENT TAKE?

- Approximately 7-10 Business days

- a) Complete all Provider Information (Name, Title, Address, Email, Phone, PTAN(s), & NPI(s))
- b) Select Submitter Status (New Submitter or Existing Submitter)
- c) Fill in the remaining submitter information as follows:
 - Submitter ID: CH0000586
 - Submitter Name: Office Ally
 - Submitter Type: Clearinghouse
- d) Read the CMS EDI Enrollment Agreement Information, and check the box indicating you have read and accept the terms of the agreement.
- e) Select Submit and follow the directions provided.
 - i. After clicking the submit button you will be required to print the form, sign and date it, and then fax it to the EDI Enrollment Department at the Fax number listed on the form. The signed form must be received with 10 days of completing the online form. Any forms that are not signed and faxed to NGS within 10 business days will be rejected.

HOW DO I CHECK STATUS?

- Call 877-273-4334 and ask if provider ID has been linked to submitter ID **CH0000586**
- Approval notices will be sent directly to the provider via email to the email address provided on the application.
- Once you have been linked to Office Ally, you **MUST** notify Office Ally **PRIOR** to submitting claims. Call Office Ally at 866-575-4120, option 1 and notify them of the approval.

Once you have confirmed with the insurance payor that your provider number is linked to Office Ally please fax the following information to My Clients Plus at 888-653-7115.

- **My Clients Plus**
- **Provider/Practice Name as pre-enrolled with the insurance payer**
- **Fed Tax ID**
- **Billing NPI**
- **Insurance Payer (including State if BCBS, Medicare or Medicaid).**
- **The statement “I have verified my provider ID has been linked to Office Ally with the Insurance Payor”.**
- **Provider email address where you can be notified of setup completion.**
