

# MEDICARE WASHINGTON PRE-ENROLLMENT INSTRUCTIONS – MR006



Noridian is requiring that all providers use their new Total OnBoarding System for all EDI operations. In order to use this system you must:

1. Open your internet browser and go to: <https://noridian.totalonboarding.com>
2. Log into Total OnBoarding with your assigned user name and password.
  - a. If you do not already have an account click on “Create a new Provider/Vendor account”
    - i. Follow the instructions outlined in the [Provider User Guide](#). For an Online Tutorial: [http://www.edissweb.com/docs/shared/tutorials/tob/provider\\_registration/index.htm](http://www.edissweb.com/docs/shared/tutorials/tob/provider_registration/index.htm)
  - b. You must elect Office Ally as your clearinghouse when enrolling with Total OnBoarding. The instructions on how to do this are outlined in the [Provider User Guide](#). You MUST add Office Ally as your clearinghouse (vendor) in the manage vendors tool in order for Office Ally to submit claims on your behalf to any of the aforementioned states for Medicare Part B, administered by Noridian.

## HOW LONG DOES PRE-ENROLLMENT TAKE?

- 7 to 10 business days

## WHERE SHOULD I SEND THE FORMS?

## WHAT FORM SHOULD I DO?

- The forms that you need to complete will be listed on the home screen, after you have logged into Total OnBoarding. Click on “View Forms” under the Action column. Now you can download and complete the appropriate forms.

## HOW DO I CHECK STATUS?

- To check status, call Medicare at 800.967.7902 or email Medicare at [edi@noridian.com](mailto:edi@noridian.com) and ask if your provider number has been linked to Office Ally, trading partner ID CH00102.
- If it has been linked, ask find out the submitter number assigned to them, and call Office Ally with this information **before** submitting claims.
- Both their provider number and the submitter number are needed in order to enter the approval into our system.

Once you have confirmed with the insurance payor that your provider number is linked to Office Ally please fax the following information to My Clients Plus at 888-653-7115.

- **My Clients Plus**
- **Provider/Practice Name as pre-enrolled with the insurance payer**
- **Fed Tax ID**
- **Billing NPI**
- **Insurance Payer (including State if BCBS, Medicare or Medicaid).**
- **The statement “I have verified my provider ID has been linked to Office Ally with the Insurance Payor”.**
- **Provider email address where you can be notified of setup completion.**
